REGULATIONS AND DISCLAIMER

- a. A parent or guardian must accompany applicants under 18 years of age. The parent or guardian must co-sign the entry form.
- b. As affiliated Clubs of the Kennel Union of South Africa (KUSA), the usual code of ethics will apply.
- c. The dog entered for the Event is entered entirely at your own risk. Accordingly, unless specifically authorised to be off-lead by a Judge while participating in a test as part of the Competition or while engaged in a practice session prior to participating in the Competition, you shall ensure that the dog entered is at all times properly confined, either in an animal crate of suitable size, or on a lead/leash, either hand-held or securely anchored.
- d. You acknowledge that a dog is capable of causing damage, injury or harm to other dogs, persons or property at the Event, and you accept full responsibility for the safety and behaviour of the dog entered for the duration of the Event, to the extent that you accept personal liability in respect of any claim made in respect of any damage or injury caused by the dog and/or your failure to adequately prevent such catastrophe.
- e. You indemnify the Event-holding Clubs and its Officers, and any employee(s) of the Clubs, against any and all claims of whatsoever nature and howsoever arising that may be levelled against them, jointly or severally, in respect of any damage or injury or harm caused by the dog entered and/or any failure on your part to adequately control the dog, or arising out of any act, omission, conduct or utterance by you, your appointed agent(s), handler(s), representative(s) or employee(s).
- f. The Venue was made available with the kind allowance of the Farm Owner. Please drive carefully, stay on the road appropriately indicated and respect all people, employees, animals, and equipment on the farm. Gates opened by you must be closed after you drive through. The Venue needs to be left as we have found it, pick up all litter. Litter bags will be available at the registration table.
- g. We accept no responsibility for children at the Venue. It is the supervising adult's responsibility to ensure the children's safety at all times.
- h. You are fully responsible and liable for any damage, injury, or harm caused to any person, animal or property arising out of any action by a minor child for whom you are legally responsible and who may be accompanying you or handling the dog entered, such legal responsibility to continue for the duration of the Event and thereafter during the continued presence of the child on the venue where the Event is held. You indemnify and hold harmless the Event-holding Clubs, and the Officers and employees of the Clubs, against any and all claims of whatsoever nature and howsoever arising that may be levelled against them, jointly or severally, in respect of any damage, harm or injury caused by any minor child for whom you are legally responsible at the Event.
- i. You are fully responsible and liable for any damage, injury, or harm caused to any person, animal or property arising out of any action of a you, the dog entered or person attending the Event as your employee, assistant, or guest on the grounds or in the buildings or amenities where the Event is held.
- j. The Event premises, buildings and amenities are entered entirely at your/their own risk.
- k. All dogs and puppies should be suitably vaccinated and appropriately treated for internal and external parasites.
- l. You confirm that your dog has neither suffered from nor been exposed to any infectious or contagious disease(s) within six (6) weeks prior to the Event or is suffering from such disease(s) at the time of the Event.
- m. Bitches in season are not permitted to attend a class.
- n. Photographs may be taken and published by the Clubs. Photographs will be made available to competitors at nominal cost.
